

# Terms of Service

## LGM Analytics / Lottery Guess Master

Effective / last updated: September 8, 2026

These Terms govern use of the LGM Analytics / Lottery Guess Master website, digital membership services, and related tools.

### 1. Service and eligibility

LGM Analytics / Lottery Guess Master provides digital membership access, number insights, daily insights, daily sheets, free preview sheets, pattern-analysis tools, Big Game Analysis, and educational number-pattern content. The service is for informational, organizational, educational, and entertainment purposes only. No physical product is shipped.

You must be at least 18 years old and legally permitted to use the service in your jurisdiction.

### 2. Lottery and results disclaimer

Lottery results are random and unpredictable. LGM Analytics does not promise or guarantee any winning result, prize, payout, profit, or other outcome. LGM Analytics does not sell lottery tickets, process wagers, accept bets, collect stakes, pay winnings, or operate a lottery or gambling service, and is not affiliated with an official lottery organization. Users remain responsible for their own decisions and participation.

### 3. Accounts and member access

Some features require an LGM account. You are responsible for keeping your login credentials secure and for activity under your account. Paid content and member access are for the purchasing member and may not be copied, shared, resold, redistributed, or used to provide unauthorized access to others. Device and account-access limits may apply.

### 4. Billing, subscriptions, and time-limited access

Current prices, billing frequency, and plan terms are shown at checkout. Monthly subscription plans renew automatically at the applicable recurring price until canceled. Cancellation prevents future renewal charges but does not normally reverse a completed billing period. Access generally continues through the paid period unless the payment is refunded, reversed, charged back, or otherwise invalidated.

LGM may also offer one-time, time-limited access plans. Those plans do not automatically renew unless the checkout clearly states otherwise and end at the stated access expiration date.
